

ARTICLES OF INCORPORATION

OF THE

IRIS SALTZMAN CENTER, INC.

(A corporation not-for-profits)



The undersigned hereby certifies that the following are the Articles of Incorporation of Iris Saltzman Center, Inc., a Florida not-for-profit corporation (the "Corporation"), which:

ARTICLE I, NAME AND ADDRESS OF PRINCIPAL OFFICE

The name of this corporation is <u>Iris Saltzman Center</u>, Inc. Its principal office and mailing address is 905 Brickell Bay Drive #230, Miami, FL 33131

ARTICLE II, ENABLING LAW

This Corporation is organized pursuant to Chapter 617, Florida Statues, as a corporation not-for-profit.

ARTICLE III, PURPOSE AND POWER

The purpose for which this Corporation is organized are:

A. Exclusively charitable, cultural, literary and educational within the meaning of S 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States Internal Revenue Law) (the "Code"), and notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt form Federal Income Tax Under Code S 501(c)(3), contributions to which are deductible for federal and state income, gift and estate tax purposes.

- B. The Corporation's purposes shall include, but are not limited to:

- To raise funds to support the aforementioned activities memberships are offered. There are three levels of memberships, Green, Yellow and Purple. All access is restricted to paid memberships for certain events. Members receive discounts for all classes not services. Other forms of raising money will be by obtaining government grants and aid if applicable, donations from private individuals, donations of money, property.
- To do all such acts as are necessary to carry out the purposes set forth in these Articles of Incorporation and as are permitted by law and the Code

or its corresponding treasure Regulation for an entity which qualifies under Code S 501(c)(3).

- C) This Corporation is a not-for-profit corporation organized pursuant and shall be operated exclusively for educational, charitable, scientific and literary purposes.
- D) This Corporation does not contemplate any pecuniary gain or profit to members, directors of officers thereof and no part of any earnings of the Corporation shall inure to the benefit of, or be distributable to, any member, director or officer of the Corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation and the Corporation may reimburse its directors and officers for all expenses reasonably incurred in performing services rendered to the Corporation), and no member, director or officer of the Corporation, or any other private individual, shall be entitled to share the distribution of any not for profit corporation described in code 501(c)(3) and 170 (c)(2) as specified below.
- E) No substantial part of the activity of the Corporation shall include or consist of the carrying on of propaganda or other wise to influence legislation. This corporation shall not participate in or intervene in or do any other act in connection with any political campaign on behalf of any candidate for public office (including without limitation the publication or distribution of statements for or against any candidate)
- F) All the property of this corporation is and shall be irrevocably dedicated to charitable, scientific, literary or educational purposes, and in the event of a dissolution of this Corporation, the assets shall, after paying or making provisions for all the liabilities of the Corporation, be distributed to one or more organization which are organized and exist exclusively for educational, scientific, charitable, or literary purpose, which at the time of such dissolution, qualify as an exempt organization under code 501(c)(3), 170 (c)(2) and 509(a)(1) or (2) or any corresponding section of any prior or future Internal Revenue Code, or to the United States, the State of Florida, the county of Miami Dade or other local government for exclusive public purpose. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction exclusively for such charitable purpose, as said shall determine. In no event shall the assets or the property of the Corporation or the proceeds of such assets or property, upon dissolution, go or be distributed to the members of the Corporation, either for reimbursement of any sums subscribed, donated or contributed by such member or for any other purpose.

ARTICLE IV - TERM

The period of duration of the Corporation is perpetual unless dissolved according to law
