



- ONE:* The name and address of this principal Corporation is THE ANDRE' ALEXANDER FOUNDATION, INC. at 6488 SW 25th Street, Miramar FL 33023 in BROWARD County. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.
- TWO:* This Corporation is a non-profit public benefit Corporation and is not organized for the private gain of any person. The Corporation is organized under the Non-profit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but **shall not be limited to:** Community Enhancement, Housing Assistance, Employment, Literacy, Counseling, Substance Abuse Awareness and Prevention, Tutoring, Care for Terminally Ill Children, Assistance to Families and other programs to aid those in need.
- THREE:* The duration of this Corporation shall be perpetual, with no stock and shall have no members.
- FOUR:* The address of the registered office is 1050 NE 215th Street, Miami, Florida 33179, and the name of the Registered Agent of the Corporation shall be:

- FIVE:* (1) This Corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (2) Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a Corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by Corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
