AMENDED

Pursuant to the provisions of section 617.1002 and 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its present articles of incorporation.

MANNER OF ADOPTION

The amendments were adopted by the members and the number of votes cast for the amendment was sufficient for its approval.

These amended articles of incorporation were adopted by the board of directors of the said organization at a regular meeting with a quorum being present which was held on 07January08. This meeting of the board of directors met the requirements of both the Articles of Incorporation and the bylaws.

Article 1.

The Name of the corporation is **NEIHGBORHOOD PARTNERSHIP for ASSISTED HOUSING CORPORATION**. This is an amendment to the name of the organization formally known as **OPPORTUNITIES ABOUND** in **CAREERS, INC.**

Article 2.

The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

Article 3.

The street address of the registered office is 9223 54th CT East, Parrish, FL 34219. The registered agent at such address is Wenston B. DeSue. The county of the registered office is Manatee.

Article 5.

The corporation will not have members

The organization is organized for the purpose of charitable, developmental and educational purposes under section 501(c)(3) of the Internal Revenue Code. The purposes of this corporation also includes providing for safe, decent and affordable housing choices to low to moderate income persons, as well as developmental improvements for said purpose.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carry on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future tax code.
