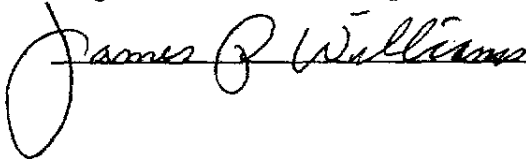

## ARTICLES OF INCORPORATION

### ARTICLE III

Purposes; The specific purpose(s) for which the corporation is organized is (are):

The Corporation is constituted so as to attract substantial support from contributions, directly or indirectly, from representative number of persons in the community in which it operates and has not been formed for pecuniary profit or financial gain, and no part of the assets, income or profit of the Corporation is distributable to, or inures to the benefit of, its directors or officers except to the extent permitted by the Florida Not-for-Profit Corporations Act. No substantial part of the activities of the Corporation shall be the carrying on of propoganda or otherwise attempting, to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from Federal income tax under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law); or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

The purpose for which the Corporation is to be formed is to promote and foster the education and rehabilitation of individuals for entry into the work force and to educate, promote and encourage rehabilitation services in the community. The corporation will have outreach programs in state prisons, hospitals, juvenile homes, old folks homes, etc. This corporation was raised up because of the great burden of souls; raised up to equip, teach, train, ordain God's people in sound doctrine, called to make a difference in our area. To the end, the Corporation will establish, organize, operate and maintain, without profit to the Corporation, a rehabilitation clinic, will present seminars and clinics, distribute newsletters and otherwise encourage the growth of education in this area. In addition, the Corporation may do any and all other acts permissable and proper under the Florida Not-for Profit Corporations Act, including but not limited to the leasing of property, purchasing and owning and operating of real estate, soliciting of donations and the acceptance of money and personal property in aid of purposes of this Corporation.
