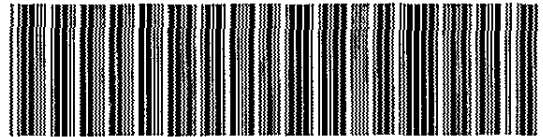

**ARTICLE I--NAME**
