

The undersigned incorporators of these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**Article I. Name**

The name of this corporation is Free Spirit Evangelistic Temple, Inc.

**Article II. Principal Office**

The principal place of business and mailing address of this corporation shall be: 280 Day Avenue, Jacksonville, Fl., 32254, with a mailing address of, 280 Day Avenue, Jacksonville, Fl., 32254.

**Article III. Purpose**

This corporation is organized exclusively for charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, including but not limited to:

1. Serving as an outreach ministry, working through the community to strengthen and unify the community both spiritually and physically through means of Biblical teaching and community reaching out, to serve the youth of the community by providing activities which will assist them in their outlook and daily living, to provide food, shelter and clothing for the homeless, ministering to those on drugs and alcohol and other addictive substances, providing spiritual and educational opportunities for children and other underprivileged persons, and assisting both the membership and others in the community in strengthening both marriage and family unity.
2. To recruit, refer and place like minded individuals who are willing to assist, serve or contribute to the needs and unification of the community.
3. Notwithstanding anything to the contrary herein contained, this corporation shall have the power to do any and all incidental acts and things and to exercise any and all other powers which a partnership or natural person doing business on a non-profit basis could do or exercise as may be authorized by law, and shall possess such general and

additional powers as are conferred by the laws of the state of Florida upon non-profit corporations which are likewise and similarly organized, subject to the provisions of Section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1954, as amended; provided, however, that this corporation shall be operated exclusively for the attainment of its stated objectives shall not carry on any activity not permitted to be carried on by a corporation exempt from Federal and State taxation.

#### Article IV. Manner of Election

At the onset of the ministry Directors will be appointed by the Presiding Bishop. Upon growth of the ministry amendments will be issued to allow for a corporate vote.
