Pursuant to sections 617.140 and 617.1406, Florida Statutes, this Florida Not for Profit corporation submits the following Articles of Dissolution and states as follows:

1. The name of the Corporation is:

4. All debts, obligations and liabilities of the Corporation have been paid, discharged or adequate provision has been made therefore.

The number of Directors that attended the meeting was two and the vote for dissolution and distribution of assets was unanimous by those in attendance.


