## ARTICLES OF INCORPORATION OF\_

#### Breath of Life Creative Ministries Inc.

(A Florida Corporation Not for Profit)

#### ARTICLE I NAME:

The name of the corporation shall be: Breath of Life Creative Ministries Inc ARTICLE II PRINCIPAL OFFICE:

The principal place of business and mailing address of this corporation shall be: 1603 Nachez Trace Blvd., Orlando, FL 32818.

#### ARTICLE III PURPOSE:

The purpose for which the corporation is organized is to:

- 1. Educate and equip children and adults to exercise their creative abilities for use in their local worship services.  $\equiv$
- 2. To disseminate the Gospel of Jesus Christ and the word of God that people may be conformed to the image of Christ.
- 3. To act with charitable concern for women and children to develop and carry out programs of ministry to the poor, widowed, orphaned, afflicted and imprisoned under privileged or aged persons.
- 4. To pray for the needs of all people, for local and national leaders and governments.
- 5. To recognize, support and cooperate with the various ministries established by God to equip believers to fulfill their respective functions as members of the body of Christ.

### ARTICLE IV MANNER OF ELECTION:

The affairs of this corporation shall be directed by a governing body which shall consist of not less than three members and not more than 12 members appointed by the President of the Corporation for a term of one year. The affairs shall be administered by its officers, which shall be President, Vice-President, and Secretary/Treasurer; and such other assistant or administrative officers as determined by the President. The President shall hold this office indefinitely. The Vice President and Secretary shall hold their position for a term of one year. At the end of that one year term, the President may

appoint a new officer or re-appoint the officer already in that position.
