ARTICLES OF INCORPORATION
OF
Breath of Life Creative Ministries Inc.
(A Florida Corporation Not for Profit)

ARTICLE I NAME:

The name of the corporation shall be: Breath of Life Creative Ministries Inc.

ARTICLE II PRINCIPAL OFFICE:

The principal place of business and mailing address of this corporation shall be: 1603 Nachez Trace Blvd., Orlando, FL 32818.

ARTICLE III PURPOSE:

The purpose for which the corporation is organized is to:

1. Educate and equip children and adults to exercise their creative abilities for use in their local worship services.
2. To disseminate the Gospel of Jesus Christ and the word of God that people may be conformed to the image of Christ.
3. To act with charitable concern for women and children to develop and carry out programs of ministry to the poor, widowed, orphaned, afflicted and imprisoned under privileged or aged persons.
4. To pray for the needs of all people, for local and national leaders and governments.
5. To recognize, support and cooperate with the various ministries established by God to equip believers to fulfill their respective functions as members of the body of Christ.

ARTICLE IV MANNER OF ELECTION:

The affairs of this corporation shall be directed by a governing body which shall consist of not less than three members and not more than 12 members appointed by the President of the Corporation for a term of one year. The affairs shall be administered by its officers, which shall be President, Vice-President, and Secretary/Treasurer; and such other assistant or administrative officers as determined by the President. The President shall hold this office indefinitely. The Vice President and Secretary shall hold their position for a term of one year. At the end of that one year term, the President may

The officers serve at the pleasure of the governing body; provided, however, that any persons dealing with the corporation shall be entitled to rely on the documents signed on the behalf of the corporation by its President with its corporate seal thereto affixed and attested to by its secretary.




