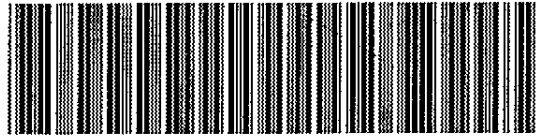

In compliance with Chapter 617, Florida Statutes (Not-for-Profit), these Articles of Incorporation set forth the following:

ARTICLE I: NAME

The name of the corporation shall be NEW HOPE CITY MINISTRIES, INC.






