The name and address of this principal corporation is SOUNDS OF ZION COMMUNITY MARCHING BAND, INC, 1269 NW 123RD Terrace, Pembroke Pines, Florida 33026, in Broward County. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

ARTICLE TWO



The duration of this corporation shall be perpetual no stock and shall have no members.




ARTICLE EIGHT

of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.




