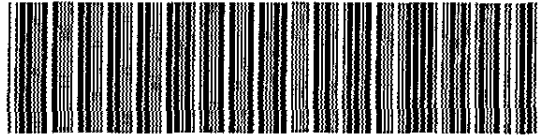

# ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida  
Nor for Profit Corporation Act, hereby adopts the following Articles of Incorporation.*

## ARTICLE I

### Name

The name of the corporation shall be:

Last Days World Outreach, Inc.

## ARTICLE II

### Principal Place of Business and Mailing Address

The principal place of business and mailing address of this corporation shall be:

## ARTICLE III

### Purposes(s)

The specific purpose(s) for which the corporation is organized are:

- A - Exclusively religious within the meaning of Section 501(a), of the Internal Revenue Code of 1986, as amended, as described in Section 501(c)(3), as outlined in those specific articles within the F.S. 1997, Chapter 617, Florida Division of Corporations, and further expressed in the corporation's Articles of Association, By-Laws and Statement of Faith;
- B - To provide a means for the propagation of the Scriptures;
- C - To provide facilities to aid the indigent, mentor new disciples, study the Scriptures, engage in worship services, and other related activities.

## ARTICLE IV

### Manner of election of Directors

The manner in which the directors are elected or appointed is:

The corporate powers of the corporation are as provided in Sec 617.0302, F.S. 1997, unless limited as follows:

Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Sec 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law.

## ARTICLE V - cont'd

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Sec 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes, or to such organization(s) as such court shall determine, which are organized and operated exclusively for such purposes.
