Please accept this letter as our legitimate excuse for not renewing the captioned subject on the specific date of May, 2003.

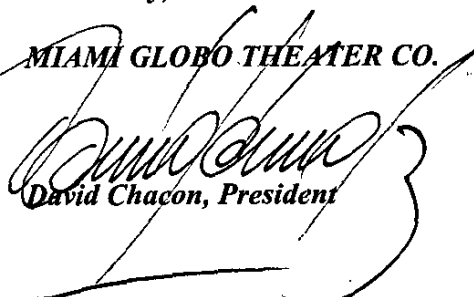
For your ready information, we never received the renewal form that you mailed; chances are that it could be an error from the postman on the apartment number.
