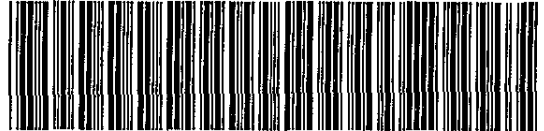

ARTICLE III PURPOSE


This corporation is a Nonprofit Public Benefit corporation and is not organized for the private gain of any one person. This corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purpose to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs are designed to educate the mind, nurture the spirit, foster development of the whole child with the involvement of the entire family.

On dissolution or winding up of the corporation, its assets remaining after payment of or provision for payment of , all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Charitable and Education under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of county in which the principal office of the organization is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
