#### ARTICLES OF INCORPORATION

#### **ARTICLE I**

Section 1.

The name of the Corporation is Casa Loma. Inc. The corporation has been organized under The Florida Not-ForProfit Corporation Act, Florida Statutes Chapter 617, and the Corporation shall be operated in accordance therewith and in accordance with Florida Statutes Chapter 720.

#### **ARTICLE II**
