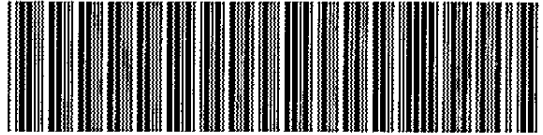

**ARTICLES OF INCORPORATION  
OF  
ALL OUTREACHES, INC.**

**KNOW ALL MEN BY THESE PRESENTS:** That the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby present these Articles for the formation of a Corporation Not for Profit, under the laws of the State of Florida.

ARTICLE I

The name of the Corporation Not for Profit shall be

**ALL OUTREACHES, INC.**

ARTICLE II

The purpose for which this Corporation is to be formed are exclusively charitable, to wit:

(a) To accept, hold, sell, resell, and administer any gifts, bequests, devised, benefits or trusts (but not to act as Trustee of any Trust), and property of any sort, without limitation as to amount or value, and to use, disburse or donate the income or principal thereof for exclusively charitable purposes;

(b) Alone or in cooperation with other persons or organizations to do any and all lawful acts and things which may be necessary, useful, suitable or proper for the furtherance, accomplishment or attainment of any or all of the purposes or powers of the corporation;

(c) In general, to do any and all acts and things, and to exercise any and all powers which may now or thereafter be lawful for the Corporation to do or exercise under or pursuant to the laws of the State of Florida or of the United States, for the purposes of accomplishing any of the purposes of the Corporation.

ARTICLE III

**Qualification of Members:** This Corporation shall have no membership requirements, in that same is being organized for the sole purpose of raising funds for the purposes herein set forth. Participation in Corporation shall be solely voluntary and shall be open to all persons who share the concern for the needy families of the Daytona Beach area of Volusia County, Florida.

#### ARTICLE IV

The initial street address of the principal office of this Corporation in the State of Florida is 23 Brookwood Dr., Ormond Beach, Florida, 32174. The Board of Directors may, from time to time, move the principal office to any other address in the State of Florida.

#### ARTICLE V

This corporation shall have perpetual existence.

#### ARTICLE VI

(A). This Corporation shall have a President, who shall be a director, and a Secretary/Treasure. The officers of the Corporation shall be chosen by the Board of Directors at the Annual Board of Directors meeting, and shall serve until their successors are chosen and qualify. Any person may hold two or more offices.

#### ARTICLE X

By-Laws: The By-Laws of the Corporation shall be made, adopted and approved by the Board of Directors. The Board of Directors, by a majority vote, may alter or rescind any or all of said By-Laws.

#### ARTICLE XI

Amendments: The Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be in writing and approved by a majority vote of the members of the Board of Directors.

#### ARTICLE XII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or any future Internal Revenue code, or to the federal, state or local government of exclusive public purpose.

#### ARTICLE XIII

The person who will manage the affairs of the Corporation is Marlene J. Ackerman, as its President. The managing officers shall be elected or appointed on January 2 of each and every year.

#### ARTICLE XIV

Notwithstanding any other provisions of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, or (b) a Corporation contribution to which are deductible under Section 170(c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any United States Internal Revenue Law.






