# ARTICLE OF INCORPORATION OF MARANTHA EVANGELICAL CHURCH, INC.

The UNDERSIGNED, natural persons of legal age acting as incorporators of a not-for-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such applicable corporation.

#### ARTICLE I- NAME

The name of this corporation is MARANTHA EVANGELICAL CHURCH, INC. ARTICLE II- DURATION

The period of its duration is perpetual.

#### ARTICLE HE NATURE OF BUSINESS

The purpose(s) for which this corporation is organized are: "To operate a NOT-FOR-PROFIT RELIGIOUS ORGANIZATION WHICH BELIEVES IN ONE GOD, IN THE TRINITY, THE BAPTISM AND ONE FAITH IN GOD. AND WE BELIEVE THAT WE ARE AMBASSADORS FOR CHRIST ON EARTH.

## ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are qualified, elected or appointed is as follows:

Each year at its General Annual Meeting, the members of the corporation shall elect a board of directors to serve for the ensuing year as provided for in the by-laws.

### ARTICLE V- REGULATION OF INTERNAL AFFAIRS

The Internal affairs of the corporation are governed by the "BY-LAWS" which shall be established and approved by a majority of the directors at the first meeting of the board of directors.

#### ARTICLE VI-LIMITATION CORPORATE POWERS

The corporate power of this corporation are as provided in section 617.0302, Florida Statutes. There are no provisions limiting the powers of the corporation except as prohibited by section 617.0833

Section I.

This corporation shall be operated and governed by a Board of Directors. The by-laws may provide another name for the Board of Directors, and

otherwise provide for the extent and limit of their powers, duties and privileges, and, futher, shall provide the manner of appointment, qualification or election and other matters relating thereto, subject to restrictions herein, including:

- a. The number of directors may be provided for in the by- laws but shall at times not be less than six (6);
- b. All changes must be ratified by two thirds (2/3) of the membership of the corporation.
