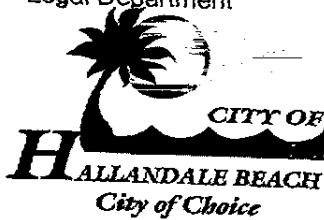

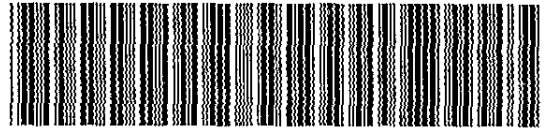

The Registered Agent and his address for the corporation is:


