To promote civic education with special attention to creating a greater awareness of the meaning of democracy and its ideals, to the relationship of economics and democracy. To empower our Haitian immigrants by assisting them through the U.S. naturalization process. To develop mechanism for involving the community and elected officials in dealing with issues, concerns, and problems as they are identified.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
