AMENDED AND RESTATED ARTICLES OF INCORPORATION OF INDEPENDENT COLLEGES AND UNIVERSITIES BENEFITS ASSOCIATION, INC. (A Corporation Not For Profit)

Pursuant to the provisions of Section 617.1002 of the Florida Not For Profit Corporation Act, (the "Act") Independent Colleges and Universities Benefits Association, Inc., a Florida not for profit corporation (the "Corporation"), hereby adopts the following amended and restated articles of incorporation, (the "Articles of Incorporation"):

ARTICLE I

The name of this not for profit corporation is the Independent Colleges and Universities Benefits Association, Inc. (hereinafter "ICUBA").

ARTICLE II PRINCIPAL OFFICE

The address of the principal office and the mailing address of ICUBA is:

ARTICLE III PURPOSE

ICUBA is formed for all lawful and charitable purposes, including the following:

- (a) To establish, maintain, administer, construe and interpret a health and welfare benefit plan (hereinafter the "Plan"), which shall be for the exclusive benefit of the Participants, their Dependents and Beneficiaries.
- (b) To establish and maintain a Trust Fund in which all of the assets at any time held in the name of ICUBA or by the Board of Directors are to be held. All right, title and interest in and to the assets of the Trust Fund, including any life or other insurance policies, shall be at all times vested exclusively in ICUBA.
- (c) To draft other "employee welfare benefit plans" (hereinafter "Employee Welfare Benefit Plans") as that term is defined in Section 3(1) of the Employee Retirement Income Security Act of 1974, as amended.

(d) If an individual member desires to adopt an Employee Welfare Benefit Plan, to administer such plan on the member's behalf in accordance with such plan's terms.

ARTICLE IV INUREMENT

No part of the net earnings of ICUBA shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that ICUBA shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of ICUBA shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and ICUBA shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Norwithstanding any other provision of these Articles of Incorporation, ICUBA shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(9) of the Internal Revenue Code of 1986, as amended.

ARTICLE V REGISTERED AGENT AND OFFICE

The registered agent of ICUBA shall be the Executive Director of ICUBA, whose mailing address is:

ARTICLE VI BOARD OF DIRECTORS

The powers of ICUBA shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors consisting of not less than three (3) persons. The number of members of the Board of Directors may be decreased or increased from time to time in accordance with the Bylaws of ICUBA. The manner in which the Directors are to be elected or appointed shall be stated in the Bylaws.

ARTICLE VII BYLAWS

The Board of Directors shall adopt Bylaws consistent with these Articles of Incorporation. Subject to the limitations contained in the Bylaws, and any limitations set forth in the Act concerning corporate action that must be authorized or approved by the members of ICUBA, Bylaws of ICUBA may be made, altered, rescinded, added to, or new Bylaws may be adopted, either by a resolution of the Board of Directors, or by following the procedure set forth in the Bylaws.

ARTICLE VIII OFFICERS

The officers of ICUBA shall be a Chairperson, a Vice-Chairperson, a Secretary and a Treasurer, and such other officers as the Board of Directors may from time to time by resolution create. Any two or more offices may be held by the same person.

ARTICLE IX MEMBERS

The qualification and voting rights for members and the manner of their admission shall be regulated by the Corporation's Bylaws.

ARTICLE X STOCK

ICUBA shall be organized on a non-stock basis.

ARTICLE XI DURATION

The term of existence of ICUBA is perpetual.

ARTICLE XII DISSOLUTION OF THE CORPORATION

Upon the dissolution of ICUBA, any assets remaining in the Trust Fund:

(a) after the satisfaction of all liabilities to existing Participants, Dependents, or their Beneficiaries shall be applied to provide such Participants, Dependents, or their Beneficiaries with the benefits set forth in the Plan, either directly or through the purchase of insurance, or through the merger, consolidation, reorganization, or other transfer of assets to a successor entity as directed by the Board of Directors; provided, however, that such benefits shall not be provided in disproportionate amounts to officers, members, or highly compensated employees of ICUBA; or (b) shall be distributed to Participants, Dependents, or their Beneficiaries as soon ICUBA deems it to be in the best interests of the Participants, Dependents, or their Beneficiaries; provided, however, that such a distribution shall only be made (1) pursuant to the terms of a collective bargaining agreement or (2) on the basis of objective and reasonable standards which do not result in either unequal payments to similarly situated Participants, Dependents, or their Beneficiaries or in disproportionate payments to officers, shareholders, or highly compensated employees of ICUBA or any member.
