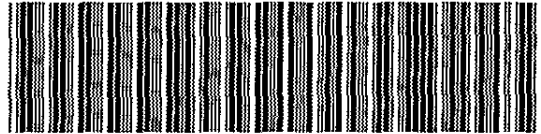

ARTICLE ONE

ARTICLE THREE

The duration of the corporation is **PERPETUAL**

ARTICLE FOUR

The purpose or purposes, for which the corporation is organized are to engage the pursuit of the promotion of the Trinidad and Tobago culture, and to perform benevolent and charitable services to the people of Trinidad and Tobago in Central Florida or in Trinidad and Tobago who the Board have determined are qualified for assistance.

ARTICLE FIVE

The membership shall consist of persons who are eighteen years or more and are native or citizen of Trinidad and Tobago and their spouse, and off spring whose application for membership has been approved by the Board of Directors.
