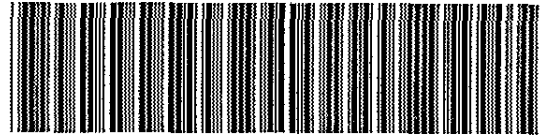



The undersigned incorporators desiring to form a Non- Profit Corporation in accordance with Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE ONE**  
**NAME**
