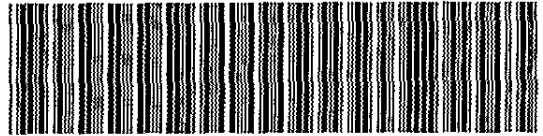

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be LifeLine Ministry Center Incorporated, a nonprofit corporation (herein referred to as the "Corporation").

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1543 40th street West Palm Beach, Florida 33407.

ARTICLE III PURPOSE

The Corporation is organized exclusively for charitable and religious purposes. The specific purpose of the corporation is the following:

- a. Provide a resource center for the public containing information on nonprofit programs and services available to assist the community.
- b. Assist nonprofit organizations (including religious organizations) with informing the public of the programs and services available in their area.
- c. Work with people to help them locate needed assistance in their area.
- d. Partner with nonprofit organizations (including religious organizations) and assist them in identifying the needs currently not being met in their area.

ARTICLE IV MANNER OF ELECTION

Board of Directors shall be appointed. All other matters relating to terms of office, removal of directors, filling vacancies on the Board of Directors, regular and special meetings of the Board, notice and waiver of notice, quorum and adjournment, and telephone meetings shall be spelled out in the Corporation's Bylaws.

ARTICLE V INITIAL DIRECTORS/OFFICERS

A three person Board of Directors shall manage the affairs of this Corporation. The number of Directors may be changed by amendment of the Articles. The initial directors' names and addresses are:
