ARTICLES OF INCORPORATION

<u>of</u>

TAMPA BAY SOAP BOX DERBY, INC.

1. The Articles of Incorporation of Tampa Bay Soap Box Derby, Inc., are hereby amended to adopt the following additional article, as follows:

ARTICLE VIII - CHARITABLE STATUS

This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision or any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under Section 170(b)(2) of the Internal Revenue code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-

profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and/or scientific purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

2. The foregoing amendment was adopted by the shareholders of this corporation on 3/14 , 2003.
