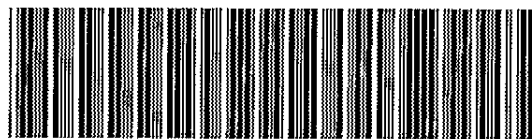

**ARTICLES OF INCORPORATION
OF**

The undersigned incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be "PSP of Leon County, Inc."

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of PSP, Inc., hereinafter entitled the "Corporation", shall be 1615 Holton Street, Tallahassee, FL 32310. of Leon County.

ARTICLE III

PURPOSE

This corporation is organized to operate exclusively for charitable, educational, literary, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The Corporation's purpose includes, but is not limited to, enhancing the cooperation of parents, teachers, and administrators in the promotion of the welfare of the children of Hargrett's Kiddie Kollege and to aid in their education. The Corporation's purpose shall be promoted through educational programs directed toward parents, teachers, and the general public.

ARTICLE IV

BOARD OF DIRECTORS

The management of the affairs of the Corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. Directors shall be appointed in accordance with the Corporation's bylaws.

ARTICLE V

REGISTERED AGENT


