**ARTICLE I: NAME**

The name of this Corporation shall be P.O.W.E.R MINISTRIES  
WORSHIP CENTER, Inc., a not for profit corporation.

**ARTICLE II: DURATION**

This Corporation shall have a duration of perpetual existence. The  
date and time of the commencement of corporate existence is when these  
Articles of Incorporation are received in the office of the Secretary of State.

**ARTICLE III: PURPOSE**

The purpose of this corporation is to:

- A) Operate as an organization of Christian religious worship,  
instruction, including but not limited to bible instruction, and  
services to its members.
- B) Operate as an organization of charity and to provide services  
and/or assistance for the public benefit, including but not limited to  
public broadcasting and publications for the purposes of religious  
outreach.
- C) Provide goods and services associated with Christian worship and  
religious practices.

**ARTICLE VI: BOARD OF DIRECTORS ELECTIONS**

The Board of Directors shall be elected by membership at each annual meeting of the members.

**ARTICLE VII: INITIAL REGISTERED AGENT**

The initial registered agent shall be Sheena Benjamin-Wise, Esq., located at the 1545 East Oakland Park Boulevard, Suite A, Fort Lauderdale, Florida 33334.

**ARTICLE VIII: INCORPORATOR**

The name and address of the Incorporator is Pastor Clemelin Smith, 8074 NW 10th Street, Plantation, Florida 33322

**ARTICLE IX: AMENDMENT**

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

**ARTICLE X: TAX EXEMPTION**

The corporation is a not for profit corporation. The specific and primary purposes for which this corporation is formed organized are:

- A) to operate as a religious organization to spiritually serve, instruct and guide the members, the provision of services and the distribution of its funds for those purposes, and particularly for the provision of religious instruction to members and the general public in South Florida.
- B) The general purposes for which this corporation is formed are to operate exclusively for charitable purposes which will qualify if as an exempt organization under Section 501(c)(3) of the Internal

Revenue Code of 1986 or corresponding provision of any subsequent federal tax laws, including, for those purposes, the making of distribution to organizations which qualify as tax exempt organization under that Code.

- C) This corporation shall not, as substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene on behalf of any candidate for public office.

#### ARTICLE XI: OFFICERS

The officers elected at the annual meeting each year to serve for the ensuing year shall manage the legal affairs of the corporation. The officers of the corporation shall serve until their respective successors in office shall be elected and duly qualified.

#### ARTICLE XII: DISSOLUTION

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under 501 (c)(3) of the Internal Revenue code of 1986 (or the corresponding provision of any future United States Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the corporation is then located, exclusively for the such purpose or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purpose.
