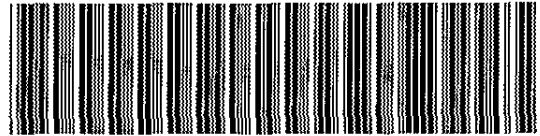

Purpose

The purpose of the church of "Jesus El Dios de Abraham" is to preach the scriptures found in the Bible from Genesis to Revelation to the souls of those people who want to live a consecrated Christian life. To enlighten our lives and the lives of those who want to be Christians, a church needs to be established to disseminate the truths of the Bible.

Belief:

The members of the church of "Jesus El Dios de Abraham" believes in the:

Holy Trinity: God the Father and Creator, God the Son (Jesus Christ our Lord and Redeemer), and God the Holy Ghost (our Counselor and Comforter).

We exist to proclaim the Gospel of Jesus Christ and provide Christian service to all people.

Through worship, education, witness, service, and support we minister within our congregation and reach out in Christ's name to all people.

We are a body of caring believers from various walks of life; growing, sharing and bound together in love and faith.

Through Word and Sacrament, our Lord Jesus Christ provides us with the love, dedication, and guidance to carry out this mission.

We rely upon God's Grace to shape us in our third century of Word and Witness.

All this we do in the Name of our Lord and Savior, Jesus Christ.

A Non-Profit Organization

The Church "Jesus El Dios de Abraham" is organized exclusively for charitable, educational religious purposes, including, for such purposes, the making of an organization that qualifies as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, or corresponding

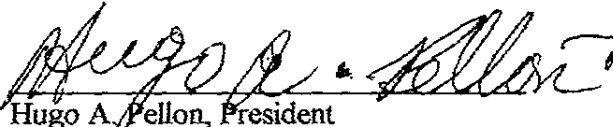

section(s) of any future federal tax code.

None of the earnings of the organization shall inure to the benefit of, or be distributable to any of its members or other private persons, and shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. None of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in, or publish and distribute statements contrary to public policy, and political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the jurisdictional Court of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization of organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
