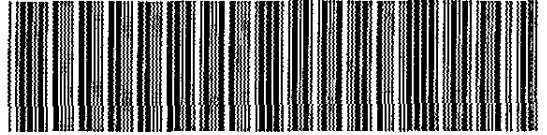



Article VIII - Functions and compensation of the board of directors

The Sankofa Learning Center is a non membership organization. All decisions pertaining to the managing of the corporation are to be made by the board of directors. The board will convene once a year to assess the year's activities of the corporation, review the budget, and plan for the upcoming fiscal year. Each board member will be compensated the cost of round trip air travel arrangements to the meeting place from his/her place of residence, meals for three days, and two nights hotel accommodations. The maximum allowable compensation per person will be determined by the board of directors, but must not exceed 5% of the corporation's profits for the given fiscal year.

Article IX - Holistic Wellness Program

In Keeping with the purpose stated in Article III, the Sankofa Learning Center shall provide the Holistic Wellness program to the public. Clients will be taught several ways to detoxify the body physically, emotionally and spiritually. Various options will be discussed; those best suited to the needs and circumstances of the individual will be identified. Once the initial detoxification has been completed, a personal modified lifestyle program including diet, exercise, prayer, and meditation will be developed and taught. The complete program includes:

- **Initial two hour consultation
- **Five additional 45 minute consultations

Article X - Natural Family Planning Program

In Keeping with the purpose stated in Article III, the Sankofa Learning Center shall provide the Natural Family Planning (NFP) program to the public. The Sankofa Learning Center NFP program focuses on teaching couples how to identify, chart and interpret the three signs of fertility. Couples will also be given a physical, spiritual and emotional assessment to cite any factors which may influence their fertility and overall health. The program includes:

- **Initial two hour consultation
- **Four additional 45 minute consultations
- **NFP Textbook and charting book
- **Digital Basal Thermometer

Article XI - Teen Abstinence Workshop and Mentorship Program

In Keeping with the purpose stated in Article III, the Sankofa Learning Center shall provide the Teen Abstinence Workshop and Mentorship Program to the public. Unlike most sex education classes, the focus of this workshop will be "understanding and respecting the power of sex and sexuality". Teens will learn about not only the physical mechanisms, but also the emotional and spiritual dynamics and consequences of sex. Special emphasis will be placed on the importance of abstinence, the many benefits of choosing to abstain, and ways to say NO. During the workshop, the teens will be encouraged to choose abstinence. Those who decide to sign an abstinence contract will become part of the abstinence mentorship program. This program is a form of Big Brother/Big Sister program where the mentors themselves have made a commitment to abstinence either in the form of premarital chastity for singles or NFP for *married persons*

Article XII - SASSUA

In Keeping with the purpose stated in Article III, the Sankofa Learning Center shall provide SASSUA as a support group for women. The women of SASSUA collectively strive to embody the meaning of her name, "one who has the will and the power of conceive and express personal desires, thoughts, and plans. Most importantly, Aisha sisters recognize that "All is One"; therefore create a support network to be able to uplift themselves and others in a holistic manner. SASUA focuses on women's health issues, holistic personal and family wellness, natural family planning, childrearing and education, and more. The activities of the organization include but are not limited to the following: Bi-monthly newsletters, Meditation Healing Sessions, Health Food Coop, Homeschool Coop, Loan Library(books, audio, video tapes on health and nutrition), Monthly Meetins. Guest Speakers/Presenters. Health Food Demonstrations

Article XIII - SABSUA

In Keeping with the purpose stated in Article III, the Sankofa Learning Center shall provide SABSUA as a support group for men. The men of SABSUA collectively strive to live the life of one who is aware and reverent of his connectedness to Amen, "the infinite source of all that is, has been and ever will be". Most importantly, Amen brothers recognize that "All is One"; therefore create a support network to be able to uplift themselves and others in a holistic manner. SABSUA focuses on men's health issues, holistic personal and family wellness, natural family planning, childrearing and education, and more. The activities of the organization include but are not limited to the following: Bi-monthly newsletters, Meditation Healing Sessions, Health Food Coop, Homeschool Coop, Loan Library(books, audio, video tapes on health and nutrition), Monthly Meetings. Guest Speakers/Presenters. Health Food Demonstrations

Article XIV - Sources of Income

Sankofa Learning Center Inc. will obtain the majority of its income from the programs listed in Articles IX-XIII and various nutritional supplements. The attached pricing list will be in effect for fiscal year 2002. Pricing may be amended by a consensus of the board of directors at any time. Sankofa Learning Center Inc. will also seek to generate income with grants, private donors, and various fund raising activities.

Article XV - Appointment of Program Coordinator and Renumeration

The Board of Directors shall appoint a Holistic Wellness Educator who will coordinate the activities of all the programs of the Sankofa Learning center Inc. That person will be paid as a consultant, a hourly rate of \$25 for the Wellness Program and the NFP program, and a flat fee of \$75 for each Teen Workshop. Rates can be modified by BOD
