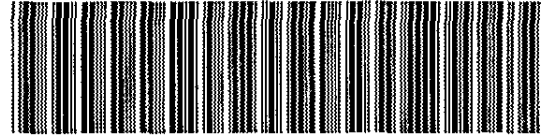

ARTICLES OF INCORPORATION
OF
PINELLAS COMMUNITY SERVICES, INC.

The undersigned persons, acting as incorporators of a corporation not-for-profit under the Florida not-for-profit corporation act, as set forth in Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I
Name

The name of this corporation is PINELLAS COMMUNITY SERVICES, INC.

ARTICLE II
Initial Principal Office

The street address of the initial principal office of the corporation shall be 7650 Gibraltar Court North, St. Petersburg, Florida 33709.

ARTICLE III
Object and Purpose

The corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, as amended (the "Code), more specifically:

To conduct all forms of legal business as a non-profit corporation within the United States of America, State of Florida, and all counties contained therein. Additionally educating and empowering individuals to improve their quality of life. This will be accomplished through synergistic partnerships with private, corporate, governmental and community-based entities. This corporation focuses its efforts upon the revitalization and transformation of community environments into economically self-sufficient, culturally enriched, and socially-balanced communities, with particular emphasis upon the economic, familial and socially-beneficial ecosystems within all counties in the State of Florida and in particular Pinellas, Hillsborough, Manatee, Pasco, and Sarasota Counties. Primary emphasis is placed upon comprehensive interventional youth activities, mentoring, building strong families, incubation of entrepreneurial enterprises, personal and business financial management, health and day care needs, and core citizenship values.

ARTICLE IV
Term of Existence

This corporation shall have perpetual existence.

ARTICLE V
Names and Addresses of Incorporators

The names and address of the incorporators to these Articles of Incorporation are:

ARTICLE VI
Management of Corporation and Time of Election or Appointment

The affairs of this non-profit corporation shall be conducted and managed by a Board of Directors, consisting of no fewer than three (3) persons, with the number elected each year and the period of service to be as provided in the Bylaws of the corporation. The officers of this corporation shall be established by the Bylaws. All of said officers shall be elected by the Board of Directors in the manner provided by the Bylaws.

ARTICLE VII
Bylaws

The corporation shall have the right to make and adopt such Bylaws as it deems proper and advisable, which Bylaws may be amended, altered or repealed in accordance with the provisions of the Bylaws, as adopted.

ARTICLE VIII
Amendments to Articles of Incorporation

The Articles of Incorporation may be amended, altered, changed or repealed in the manner now or hereafter prescribed by the Statutes of the State of Florida, and in accordance with the Bylaws of the corporation.

ARTICLE IX
General Provisions

This corporation shall have all the powers and rights conferred upon it by Statute, including but not limited to, the following: to receive, take, hold, lease, buy, sell, mortgage and convey real estate and personal property; to enter into, make and perform contracts of every kind; and to make, accept, endorse, and issue promissory notes, and other negotiable or transferable instruments and evidences of indebtedness, whether secured by mortgage or otherwise, and as permitted by the Bylaws of the corporation.

ARTICLE X
Registered Agent and Registered Office

The initial registered agent and registered office of the corporation shall be as follows:

ARTICLE XII
In Event of Dissolution

In the event of the dissolution of this corporation, all of its assets of every kind and character shall be delivered to a non-profit corporation organized exclusively for charitable, educational,

religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, as amended.
