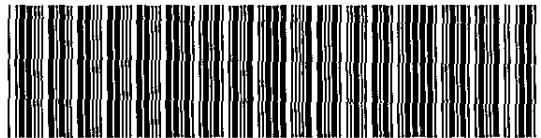

## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I      NAME**

The name of the corporation shall be:

“The Kenneth Greene Foundation, Inc.”

### **ARTICLE II      PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

### **ARTICLE III      PURPOSE**

The purpose for which the corporation is organized is:

This corporation is established to provide educational services, involving academics, social skills, cultural awareness, and the arts. It will also offer scholarships to deserving students who have received its services.

This corporation shall exist in perpetuity unless dissolved.

This corporation is organized exclusively for charitable, social, cultural and educational purposes, including for such purposes, the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

This corporation states that no proceeds of the corporation will enrich any individual, except that reasonable compensation may be paid for services to the corporation. If the corporation is dissolved, any assets remaining will be distributed to another corporation serving a similar purpose and qualifying as a tax-exempt, charitable organization under the provisions of 501(c)(3) of the Internal Revenue Code.

### **ARTICLE IV      MANNER OF ELECTION**

The manner in which the directors are election:

Directors will serve until they resign or are removed. Directors are elected by a majority vote of existing board members. The corporation will maintain five directors on its board.
