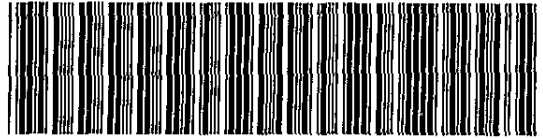

The Articles of Incorporation of Serenity Place of Love, Inc.

Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Non-profit Corporation Law of Chapter 617, Florida Statutes, do hereby certify:

Article One: The name of the Corporation shall be Serenity Place of Love, Inc.

Article Two: The place in this state where the principal office of the Corporation is to be located is 2162 Liston Ct. Orlando, FL 32811

Article Three: Serenity Place of Love, Inc. will be a faith-based organization designed to provide skilled-nursing care and rehabilitation service to individuals with special needs. Secondly, Serenity Place of Love, Inc. will aid these individuals with the activities of daily living in a congregate environment. The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article Four: The president appointed the board of directors.

Article Five: No part of the net earning of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of the purposes set forth in Article Three hereof.
