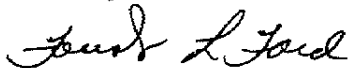

Article I

The name of this corporation shall be FUTURE MASTERS, INC.

Article II

The purposes for which this corporation is formed are:

1. The specific and primary purposes are by binding together in a united effort to provide a youth golf program, for beginners between the ages of 3-13 years old, where the basics of the game of golf, Life Skills such as sportsmanship, safety, respect and the Rules of Golf will be taught. To labor united in behalf of our community and the citizens thereof.
2. The general purposes and powers are to have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida, including the power to contract, rent, buy and sell personal or real property; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise and powers that are not in furtherance of the primary purposes of this organization.

Article VII

This corporation is one which does not contemplate pecuniary gain or profit to the members thereof, and it is organized solely for non-profit purposes. Upon winding up and dissolution of this corporation, the remaining assets shall be vested in the MetroWest Church of the Nazarene, Inc., a nonprofit organization, or in the event the MetroWest Church of the Nazarene, Inc., is not in existence, to the Frontline Outreach Center, Inc., a nonprofit organization which has established its' exemption from tax under Section 501(c)(3) or 501(c)(4) of the Internal Revenue Code. If the corporation holds any assets on trust, such assets shall be disposed of in such manner as may be directed by decree of the Circuit Court of the County in which this corporation's principal office is located upon petition therefore by the Attorney General or by any person concerned in the liquidation.

Article VIII

These articles may be amended in the manner prescribed by the laws of the State of Florida.

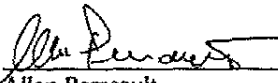

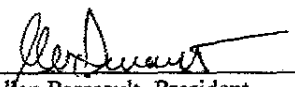
