

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME
The name of the corporation shall be:

CITRUS PARK COMMUNITY CIVIC ASSOCIATION INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

1. To encourage members to unite in promoting community civic improvements thru the active participation of all of its citizens, by conducting monthly meetings within the community.

2. To foster and promote activities by its members which will enhance the quality of life for all residents in the Greater Citrus Park Community. (A non-incorporated platted subdivision in Hillsborough County, Florida)

- 3. To encourage member involvement in Hillsborough County governmental activities such as: The Citrus Park Neighborhood Master Plan; The Comprehensive Land Use Plan; Rezoning Petitions; Variance Petitions; support enforcement of the County Code Violations by its residents; to listen to and take appropriate action where necessary of resident concerns for the betterment of the entire community.

 4. To encourage and to participate in the observance of all National
- 4. To encourage and to participate in the observance of all National Holidays; to especially encourage the display of the United States flag on patriotic holidays such as Memorial Day, July 4th Observance, and Veterans Day. To support the "Avenue Of Flags" that have been on display along Gunn Highway and Ehrlich Road, from Sickles High School on the west. to the Veterans Expressway to the east.

 5. To encourage its members to support Hillsborough County Programs such as the "Adopt-A-Road" Litter Control Program, sponsored by "Keep Hillsborough County Clean", P. O. Box 273248, Tampa, FL. 33688.

ARTICLE IV FUND RAISING ACTIVITIES

- 1. The primary source of operating funds shall be a schedule of dues for its members.
- 2. Any fund raising activities will be utilized for the promotion of the overall welfare of all of the residents of the community.

ARTICLE V MANNER OF ELECTION OF DIRECTORS.

1. A minimum of Three (3) directors shall be required. The manner in which the directors are elected shall be as follows: A Nominating Committee of three (3) members in good standing shall be appointed by the Presiden nominees must be members in good standing for a minimum of six (6) months prior to the nomination; elections shall be held at the Annual Meeting in December, and shall be by secret ballot. Nominations from the floor will be entertained prior to the election of directors. A majority of voting members present shall elect the directors.

1. The association is organized exclusively for charitable, religious, educational, and/or scientific purposes under Section 501 (c)(3) of the Internal Revenue Code.

2. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal

ARTICLE VIII UPON DISSOLUTION Distribution of Assets:

tax code.

- 1. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3 of the Internal Revenue Code, or corresponding section of any future federal tax code, to: The Friends of the Library of Hillsborough County, Florida, provided they are still in existence and would qualify for exemption under section 501(c)(3) of the Code. In the event that The Friends of the Library of Hillsborough County, Florida, is not in existence or would fail to qualify for exemption under section 501(c)(3), the Directors shall be authorized to select another rec ipient organization which would qualify under section 501(c)(3) of the Code.
- 2. Any assets not distributed as outlined in Paragraph # 1 next above, shall be distributed to the federal government, or to a local or state government, for a public purpose.
