## ARTICLES OF INCORPORATION OF

## ST. PAUL AFRICAN METHODIST EPISCOPAL CHURCH OF LAKE ALFRED, FLORIDA, INC.

#### ARTICLE ONE

The name of the corporation shall be:

St. Paul African Methodist Episcopal Church of Lake Alfred, Florida, Inc.

#### **ARTICLE TWO**

The principal place of business for this corporation shall be:

180 Clark Road Auburndale, FL 33823-9374

#### **ARTICLE THREE**

The specific purpose for which the corporation is organized is:

The general purpose of this corporation is to foster and encourage religious worship in accordance with the principles of the African Methodist Episcopal Church; that it shall purchase, take, receive, lease take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use, or otherwise deal in and with real or personal property, or any interest therein wherever situated, in trust, for the use and benefit of the African Methodist Episcopal Church, Inc. and shall have the right to make conveyance of its property in accordance with the rules of the general body of the African Methodist Episcopal Church and the current edition of "The Doctrine and Discipline of the African Methodist Episcopal Church"; it being understood that said corporation shall not be required to accept any such donations or gifts not in harmony with the purpose and object of said corporation.

#### ARTICLE FOUR

The term of existence of the corporation is as follows:

The corporation shall have perpetual existence, unless it becomes in conflict with the laws of the African Methodist Episcopal Church, Inc. and is dissolved in the manner provided by law. In the event of dissolution of the corporation and after the payment of all debts, and monies or assets remaining shall not inure to benefit of any individual, but shall be transferred to the Orlando Florida Conference, Inc. for the African Methodist Episcopal Church, Inc.

#### ARTICLE FIVE

The manner in which the Board of Trustees and the Directors shall be appointed is as follows:

The Board of Trustees and Directors shall be appointed in accordance with the current edition of "The Doctrine and Discipline of the African Methodist Episcopal Church" and such amendments to said book as is revised and compiled by the General Conference of the African Methodist Episcopal Church, Inc. periodically and thereafter.

#### ARTICLE SIX

The bylaws that will govern the corporation are as follows:

The Bylaws that will govern this corporation are the laws as are encouched in, "The Doctrine and Discipline of the American Methodist Episcopal Church" and such amendments to said book as is revised and compiled by the General Conference of the African Methodist Episcopal Church, Inc. periodically and thereafter.

#### ARTICLE SEVEN

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:

The powers and responsibilities of the corporation are limited by the rules and regulations of the African Methodist Episcopal Church, Inc. and the current edition of "The Doctrine and Discipline of the African Methodist Episcopal Church".
