

# Articles of Incorporation Of Grace Fellowship Of Believers, Inc.

# Preamble

Whereas God, has in these last days founded His Church upon Christ Jesus, (Matthew 16:13-18, Ephesians 2:19-22, I Corinthians 3:11), built it through His people (I Corinthians 3:5-15, I Corinthians 12:12-31), gave it power and authority (Acts 1:8, Acts 2:1-11, Matthew 16:19), and unified it with internal structure (I Corinthians 12:27-31) and the Holy Ghost as its guide (John 16:13-15), that we, as the body of Christ (Ephesians 1:22-23, Roman 12:5) might present His full gospel (Matthew 28:18-20, Mark 16:15-18, Col. 1:28-28) by assisting in the implementation of the vision for this Full-Gospel Spirit-Fill Evangelical Bible Teaching Religious, Charitable, and Educational Church Ministry Corporation to which these following article of incorporation are enacted.

Therefore we, the undersigned persons of the State of Florida, each being competent, hereby form our successors and ourselves into a corporation not for profit pursuant to the statues of the State of Florida.

# Article I

The name of this church ministry corporation shall be: "Grace Fellowship Of Believers, Inc."

# Article II

The principal place of business of the church ministry corporation and its mailing address shall be: 5520 Red Bone Lane, Orlando, Florida 32801 in the county of Orange.

# Article III

This church ministry corporation shall exist perpetual.

# Article IV

Membership into this church ministry corporation shall be as govern by the by-laws of this corporation.

### Article V

The Board of Directors of this corporation shall be no less than (3) three and no more than (11) eleven.

The duties of the Board of Directors shall be the care of properties of this corporation under the guidelines of the by-laws of this corporation.

The Board of Directors shall also have the power to appoint others to help it carrying out its duties from time to time.

### Article VI

The Senior Pastor of Grace Fellowship Of Believers, Inc. shall have sole power to appoint and dismiss any member of the Board of Directors who fails to carry out his or her duties as give in the by-laws. This action shall not need a vote of approval of the church however the pastor must report his action to the church, and maybe reverse by a majority vote of two third (2/3) vote of the membership of this corporation.

# Article VII

The Senior Pastor of Grace Fellowship Of Believers, Inc. shall have the right to oversee, rebuke with all authority, reproof, correct, instruct or silent any disorderly member of the church per Act 20:28, Titus 2:15, II Timothy 3:16-17, Titus 1:10-11 and I Peter 2:15.

### Article VIII

All persons in charge of any auxiliary or ministry within this corporation must have the approval of the Senior Pastor and the church ministry membership of this corporation before he or she may become the leader of the auxiliary or ministry in question.

If the Senior Pastor and Church ministry membership fail to agree on any leader then a new selection must be made until a full agreement is reached.

### Article IX

Any disagreements and action of correction within this church ministry corporation shall be handle as prescribe in the "New King James Bible and the "New International Bible," per St. Matthew 18:15-17.

# Article X

A majority vote within this church ministry corporation shall be 50% plus 1.

# Article XI

A quorum within the Board of Directors to vote on business of this corporation shall be no less than 50% plus 1.

# Article XII

A quorum within the corporation shall be no less than 1/3 of the voting members of the body at a duly call meeting by the Senior Pastor of the body to conduct its general or special business per the by-laws of the corporation however exception shall be granted to Article VI.

# Article XIII

While maintaining its inherent right to sovereignty in the conduct of its own affairs as directed by the by-laws this corporation shall seek and voluntarily maintain a cooperative fellowship with other churches, fellowships, ministries and Christian groups that are deemed mutually benevolent and beneficial to the vision and purpose of this corporation.

# Article XIV



All department leaders, group/auxiliary or ministry leaders, board members, committee members, deacons and trustees shall be elected yearly for the coming new year, the first Friday in December.



# Article XV

Upon retirement or disability, Senior Pastor Byron R. Wilson and First Lady Sharon D. Wilson shall receive no less than 75% of their individual salaries for life plus all other retirement benefits and has the right to appoint their successor.

If the Senior Pastor die in office then all the retirement benefits of the Senior Pastor shall be given to his widow for life.
