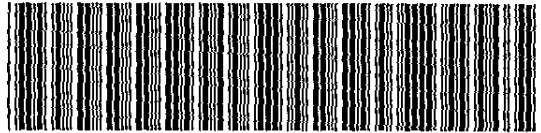

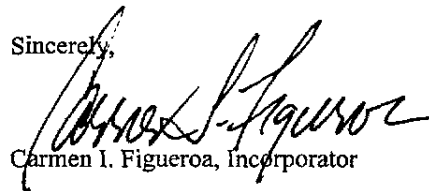

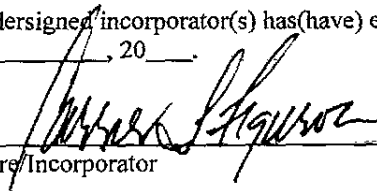
ARTICLE VIII - ASSETS

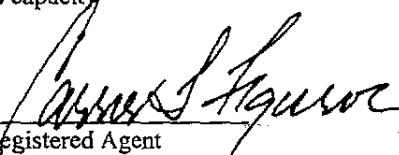
