# ARTICLE OF INCORPORATION OF ALL NATIONS REMNANT CHURCH INC.

The UNDERSIGNED, natural persons of legal age acting as incorporators of a not-for-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such applicable corporation.

# WRITICLE I- NAME

The name of this corporation is <u>ALL NATIONS REMNANT CHURCH INC.</u>

ARTICLE II- DURATION

The period of its duration is perpetual.

# ARTICLE III- NATURE OF BUSINESS

The purpose(s) for which this corporation is organized are: "To operate a NOT-FOR-PROFIT RELIGIOUS ORGANIZATION WHICH BELIEVES IN ONE GOD, IN THE TRINITY, THE BAPTISM. THE PECULIAR AND PROMINENT FEATURES OF OUR FAITH ARE THE OBSERVANCE OF THE SEVENTH DAY, AND WAITING FOR THE APPEARING OF OUR LORD JESUS CHRIST FROM HEAVEN. AS A PEOPLE WE TAKE A FIRM STAND FOR TRUTH AND RIGHTEOUSNESS. OUR MISSION IS TO GLORIFY THE NAME OF JESUS CHRIST UNTIL HIS KINGDOM IS ESTABLISHED IN HEAVEN AND EARTH.

# ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are qualified, elected or appointed is as follows:

Each year at its General Annual Meeting, the members of the corporation shall elect a board of directors to serve for the ensuing year as provided for in the by-laws.
