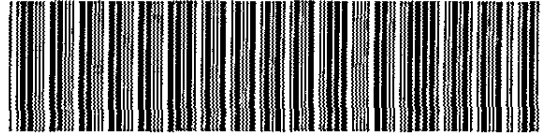

**ARTICLES OF INCORPORATION FOR THE  
MARIA LUISA PIRAQUIVE DE MORENO FOUNDATION, INC.**

The undersigned, for the purpose of forming a nonprofit corporation under Chapter 617 of the Florida Statutes hereby forms a corporation not formed for pecuniary profit and adopts the following Articles of Incorporation:

**ARTICLE I.  
NAME**

The name of the Corporation is: MARIA LUISA PIRAQUIVE DE MORENO FOUNDATION, INC. ("Corporation"). The initial principal office location of the Corporation is 10550 NW 77<sup>th</sup> Court, Suite 224, Hialeah Gardens, Florida 33016. The mailing address is the same.

**ARTICLE II.  
TERM OF EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE III.  
POWERS, OBJECTIVES AND PURPOSES OF THE CORPORATION**

This Corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes, including for such purposes, the making of distributions

to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (as such Section or corresponding Section of any future federal tax law, may be amended from time to time). The specific purposes for which this Corporation is organized are:

- (A). To assist in and contribute to the academic and physical growth and development of the Maria Luisa Piraquive de Moreno Foundation, Inc. a ministry of Iglesia de Dios Ministerial de Jesucristo Internacional, Inc.
- (B). To provide financial assistance to the members of the church with special needs and to the students of the Bible Institute Ministerios y Dones, who through merit and the calling of the Spirit of God are needy or worthy of assistance.
- (C). To solicit gifts and bequests and to administer funds received in connection with the purposes of the Corporation.

This Corporation shall be authorized to exercise the powers permitted not-for-profit corporations under chapter 617 of the Florida Statutes; provided, however, that this corporation, in exercising any one or more of such powers, shall do so in furtherance of the exempt purposes for which it has been organized within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, and provided that this Corporation shall not carry on any activities not permitted to be carried on by (a) a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, or (b) a corporation to which contributions are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or the distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
