## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be **Sherry Renee Hunter Foundation Incorporated**

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III PURPOSE (S)

The Specific purpose(s) for which this corporation is organized is (are):

a) The purpose of the **Sherry Renee Hunter Foundation Incorporated** is to perform or advocate religious principles for family life through the Christian Church. Advancing the teaching of the Lord Jesus Christ as found in the King James Version of the Holy Bible. As a Church controlled organization, specific attention shall be given to the following areas of Christian life:

- ❖ Dating
- ❖ Marriage
- ❖ Home making
- ❖ Loving the Husband
- ❖ Loving your Wife
- ❖ Caring for Children
- ❖ Family life
- ❖ Domestic violence: Marital reconciliation or Divorce?
- ❖ Starting over: Single with children, what to do next.

- b) This ministry will conduct revivals, workshops, seminars, training, videos and multimedia venues to promote Article III, Section (a).
- c) Promote the purpose(s) of the corporation by making grants, loans, or giving property of the corporation to subordinate organizations or agencies.
- d) To receive any real property or personal property by gift, grant, of bequest from individuals, foundations, corporation, either public or private, or governmental entities, for the general purposes of the corporation and to administer such property for the purpose(s) of the corporation and its subordinates
- e) To use tithes, offering, contributions, grants, gifts, payments, or capital asset for religious, Christian ministry, educational, charitable or Christian discipleship.
- f) To do what is believe necessary and useful according to the Word of God, either directly or indirectly, in order to carry out any of the purposes of the corporation

- g) All of the foregoing purposes shall be for religious, educational and charitable purposes.

All officers and committees of said board of directors may be appointed in conformity with those articles and bylaws of this corporation. 




