The undersigned subscribers of these Articles Of Incorporation, natural persons, competent to contract, hereby associate themselves together to form a Non Profit Corporation under the Laws off the State Of Florida.

ARTICLE I: NAME

The name under which this Corporation will conduct business and be known and recognized is: Fundacion San Miguel Arcangel, Inc. English translation Foundation Saint Michael Archangel, Inc.

ARTICLE II: NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation shall be to promote the creation of groups of self help and the promotion of health, education, to promote groups for the assistance to children, people with illness, indigents, teenagers, to siist the indigenous population of South America, aged, drug addicts, elder, persons with AIDS, handicaps, and to provide the tools for these people to help themselves, and organize seminars to assist these persons to help themselves, to assist these persons in South America by working with the Fundacion San Miguel Arcangel in Argentina.

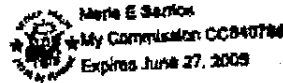
