

ARTICLES OF DISSOLUTION

Pursuant to section 617.1403, Florida Statutes, Coalition to Heal Healthcare in Florida, Inc., a Florida not-for-profit corporation submits the following Articles of Dissolution:

- 1) The name of the corporation is Coalition to Heal Healthcare in Florida, Inc. (hereinafter referred to as the "Corporation").
- 2) The Corporation has no members.
- 3) On the 4th day of February, 2004, the board of directors of the Corporation adopted a resolution authorizing the dissolution of the Corporation.

- 5) Pursuant to Section 617.1403(2), Florida Statutes, the effective date of dissolution shall be the date of these Articles of Dissolution.


