of

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non-profit corporation under Chapter 617 of the Florida Statutes.

Article I. The name of the corporation is **IGLESIA BAUTISTA NUEVA ESPERANZA, INC.** (hereinafter "Corporation"). The English translation for the above name is New Hope Baptist Church.

Article VI. The name and address of the incorporator is: Rolando Marrero, 3337 S.E. Salerno Road, Stuart, FL 34997.


