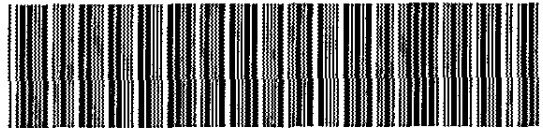

- ARTICLE 111 PURPOSE cont;

Spreading of the gospel of Jesus Christ by written letters, radio, television, video or audio tapes and any other way deemable and to buy, sell or rent such properties for the benefit and support of the work of Love Outreach Ministries Inc. Within the meaning of section 501(c)(3) of the Intrrnal Revenue code or the corresponding of any other future United State, InternalRevenue codes.

Article IV

Manner of election of directors

The manner in which the directors are elected or appointed, is as follows:

Directors must be professionals and may be; but are not limited to members of **Love Outreach Ministries Inc.**
