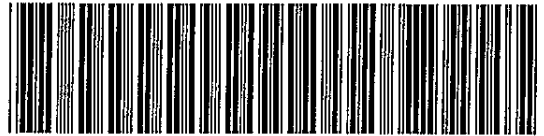

**ARTICLES OF INCORPORATION
OF

ARTICLE I

ARTICLE II

ARTICLE III

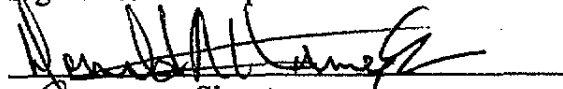

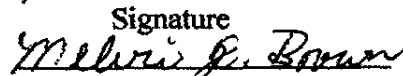
