

ARTICLES OF INCORPORATION OF

MARY CUSTIS LEE CHAPTER #1451. UNITED DAUGHTERS OF THE CONFEDERACY, INC.

NOT FOR PROFIT

ARTICLE I. - NAME

The name of this corporation is Mary Custis Lee Chapter #1451, United Daughters of the Confederacy, Inc. 3158 Gulf to Bay Boulevard, Clearwater, FL 33755

ARTICLE II. - ENABLING LAW

This corporation is organized pursuant to the Corporations Not For Profit law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

ARTICLE III - PURPOSES

- A. The specific and primary purpose for which this corporation is organized is to promote historical, benevolent, memorial and patriotic works on behalf of descendants of those who served the Confederate States of America.
- B. The general purposes for which this nonprofit corporation is formed are to assist descendants of those who served the Confederate States of America in securing education and promoting friendship within the organization.
- C. This corporation is organized and operated exclusively for descendants of those who served the Confederate States of America.
- D. This corporation shall have and exercise all rights and powers conferred upon corporations enumerated under the Florida General Corporation Act of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes as set forth in subparagraphs "A" through "C" of this article.

ARTICLE IV - TERM

This corporation shall have a perpetual existence.

ARTICLE V - INCORPORATORS

ARTICLE VI - MEMBERSHIP

The membership of this corporation shall be limited as follows: to women over 16 years of age who meet certain criteria with regard to ancestors who served the Confederate States of America.

ARTICLE VII - MANAGEMENT OF CORPORATE AFFAIRS

A. <u>Board of Directors</u>. The powers of this corporation shall be exercised, its properties controlled and its affairs conducted by a Board of Directors. The number of directors herein provided for may be changed by a bylaw duly adopted by the members entitled to vote. Directors shall be elected/appointed annually by majority vote of the memberships.

The names and addresses of the persons constituting the first Board of Directors who are to act in that capacity until the selection of their successors are:

B. <u>Elective Officers</u>. The officers of this corporation shall be a president, a First, Second and Third Vice President, Secretary, Treasurer, Registrar, Historian, Recorder of Military Service Awards and Chaplain. Other offices and officers may be established or appointed by members of this corporation at any regular annual meeting. The qualifications, the time and manner of electing or appoint, the duties of, the terms of office, and the manner of removing officers shall be as set forth in the bylaws.

C. <u>Standing Committees</u>. This corporation shall have standing committees and other committees as may be specified in the bylaws or may be appointed from time to time by the Board of Directors.

ARTICLE X - BYLAWS
