ARTICLES OF INCORPORATION

We, the undersigned, with our persons being desirous of forming a
“Not-for-Profit” corporation, under the provisions of Chapter 617 of the
Florida Statutes, do agree to the following:

ARTICLE 1. NAME

The Name of the Corporation shall be **Court Alternative Programs of
Tampa Bay, Inc.**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall

ARTICLE III. PURPOSE

The purpose of the Corporation shall include, but not be limited to, the
following:

1. To create, develop, write, organize, publish, manage and research
programs and processes to assist people in successfully completing tasks
and requirements established in various systems, such as the court
system, public health system, juvenile system or any system which
requires the public to complete certain responsibilities.
2. To assess, evaluate, review and study processes required by various
systems which are accessed by the public in order to promote, modify,
reconstruct or create an improved process to enable the end user to be
successful.
3. To establish seminars, workshops, or sessions to enlighten, educate, or
train the end users in processes which will ultimately assist and enable
them to be successful in completing tasks and responsibilities.

4. To refer, connect, introduce, inform, direct all manner of persons to receive legal counsel, medical assistance, educational direction, and various assistance to improve life quality regardless of race, sex, age or national origin.
 5. To work with all manner of persons, solvent or insolvent, literate or illiterate, criminal, physically or mentally ill, no matter race, sex, age or national origin.
 6. To do business, including all lawful business for which corporations may be incorporated under the Florida Statutes.

ARTICLE IV. MANNER OF ELECTION OFFICERS

Section 1. The manner in which the directors are elected or appointed is by nomination from the an existing officer and voted on by a majority.
