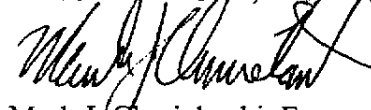

**ARTICLES OF INCORPORATION
FOR
INTERNATIONAL LASER DISPLAY ASSOCIATION, INC.**

The following Articles of Incorporation are submitted in compliance with Chapter 617, Florida Statutes (Corporations Not for Profit).

ARTICLE I: NAME

The name of the corporation shall be International Laser Display Association, Inc.

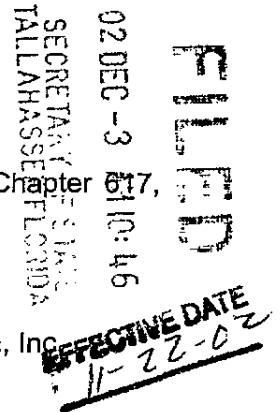
ARTICLE II: PRINCIPAL OFFICE

The principal office and mailing address of this corporation shall be: 3380 South Park Avenue, Suite #5, Titusville, Florida 32780.

ARTICLE III: PURPOSE

The purposes for which the corporation is organized are:

- a) To function as an international membership association for individuals, partnerships, firms, associations and corporations involved in and dedicated to improving and advancing the professional application of laser display;
- b) To unite those engaged in the laser display industry for the purpose of fostering and promoting the mutual interest of their profession;
- c) To develop and maintain standards of safety performance within the laser display industry;
- d) To promote a better understanding between display professionals and federal regulatory agencies such as the FDA, Center for Devices and Radiological Health (CDRH);
- e) To foster and promote the development of new technology within the industry and the advancement of laser artistry;
- f) To promote activities aimed at enabling laser display professionals to serve the entertainment and communications industries with greater efficiency;
- g) To advance ethical dealings with one another and the public by establishing a code of ethics for the laser display industry; and
- h) To encourage better understanding among the members of the laser display industry, as well as the general public, with a view toward raising the industry as a whole to a higher standard of performance.



ARTICLE IV: MANNER OF ELECTION

Directors shall be elected by the members. The By-Laws of the Corporation shall provide further details for such elections.

ARTICLE V: INITIAL REGISTERED AGENT AND STREET ADDRESS

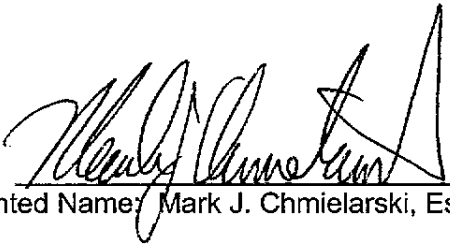
