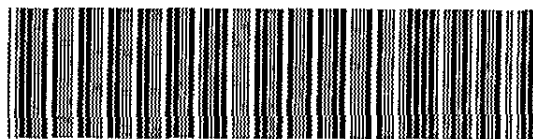



**ONE:** The name and address of this principal corporation is J. E. Watson Ministries Inc., 2310 NW 58th Street Miami Florida 33142, in Dade County. The Corporation is organized pursuant to the FLORIDA Corporation Code.

**TWO:** This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ The corporation is organized under the Nonprofit Public Benefit Corporation Law for Religious purposes. To establish structured support services Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ the Church). In accordance with the Doctrine of the Corporation creed / by-laws as a pastor to spread the gospel of Jesus Christ The religious program will consist of Economic Development programs, but shall not be limited to: Homelessness Health Care, Child Care, Youth At High Risk, Tutorial Land Acquisition, Housing, Job Training, Counseling Employment, Christian Education and other programs to aid those in need.


**SIX:** The directors are elected in accordance with the By- Laws. The names and addresses of the persons appointed to act as the initial directors of this corporation are:
