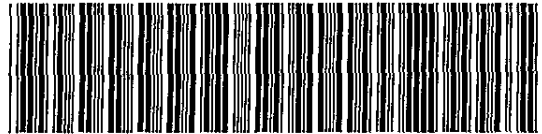

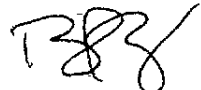

**ARTICLE VIII**

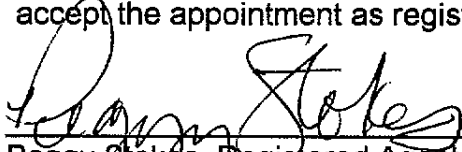
