

The undersigned for purposes of forming a non-profit corporation under the Florida Not For Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is THE CHRISTIAN MEDICAL ASSISTANCE FUND, INC..

ARTICLE II - INITIAL PRINCIPAL OFFICE

The corporation shall have its principal office at 3828 Jog Road, Lake Worth, Florida 33467.

ARTICLE III - CORPORATE PURPOSE

The corporation is organized for the purpose of raising funds primarily through donations to cover medical and rehabilitation costs for disabled youth.
